Sub: Issue of Essentiality Certificate under rule 44 of Delhi
School Education Act, 1973.

Sir,

With reference to your application on the subject
cited above, I am directed to convey the permission of the
Director of Education, Delhi to your society to establish a
new school from class Ist to VIII (without aid) in Zone-II
District North Kirari Extension Area subject to the following
conditions:

1. That the provision of DSEA/R, 1973 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfil all the conditions laid down under rule 50 and 51 of DSER 1973 alongwith provisions of Sections 4(1)(a) to (f) to the instt.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That only qualified and trained teachers will be appointed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
5. That the management of the school will not ask for grant-in-aid from the department.
6. That the school will not run for the profit of any individual association or group of persons, but for social cause.
7. That in case at any time the management of the school is unable to run the school moveable and non-moveable property of the school will be transferred in the name of Director of Education, Delhi.
8. That all the recognized classes shall be run at one place only.
9. That the management of the school will apply for grant of recognition of the school under DSEA/R, 1973 and recognition will not be granted unless statutory provisions of section 4(1)(a) to (f) read with rules 50 & 51 are fulfilled.
10. That the school shall be run under the control of P.S.M. Public School Education Society (Regd.) Delhi and suitable funds will be made available for the construction of suitable building on the land allotted to the society, as declared as per the specifications of the department with a period of three years.
11. That the recruitment of staff, teaching and non-teaching will be made as per recruitment rules of the Deptt. following reservation policy for SC & ST.

12. That the management of the school will obtain land from DDA in the name of the society through Directorate of Education, Delhi and shall construct a school building thereon for the proposed school as per the specifications of the department.

13. That adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class-room. The normal size of class-room will be 24' x 20'. No other activities other than education shall be run.

If recognition for the proposed school is not sought after fulfilling all the above conditions within a period of three years, the permission to run a new school shall be treated as cancelled.
