(without AID) w.e.f. Academic Session 1990-91.

Sir,

With reference to your application on the subject noted above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition to your school from classes Ist to VIII (without AID) w.e.f. 1990-91 session subject to the fulfilment of the following terms and conditions:-

1. That the school/office by the provisions of Delhi School Education Act and Rules, 1973 framed there under as well as the instructions issued from time to time in this regard shall be made as per the section 10(1) of Delhi School Education Act, 1973 to all the employees through crossed cheque and proof should be shown to concerned E.O.
2. That the school shall provide all facilities like medical, L.T.C. etc. to the teachers & other staff of the school.
3. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of the area concerned alongwith appropriate reservations for SC/ST categories.
4. That the school/office shall appoint more full time qualified and eligible staff for all the classes of the school as per the present norms of the Department and shall discontinue with the services of unqualified and overaged staff, if any, immediately. Proof to this effect should be provided to the E.O. for verification.
5. That the school shall equip the Science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students. More material worth Rs. 5,000/- shall be purchased during 1990-91 and a list be furnished to the Education Officer for verification.
6. That a proper Library shall be established and facilities for reading room shall also be made available for students as well as teachers. More approved standard books etc. shall be purchased. Books as per the ratio of 10 books per student may be called and facilities of reading room may also be provided immediately and more books worth Rs. 5,000/- be purchased by the start of next session and the list of books be furnished to E.O. for verification.

7. That the requisite sports material shall be purchased for out door games and in-door during the year 1990-91.
8. That the enrolment in each section shall not exceed the number of students calculated at 128ft. per student for the available floor area of the class room in the school shall provide adequate and sufficient accommodation as per the norms of the department in each class. The number of existing sections should not exceed the number of class room of proper size in the school.
9. That the school shall not realise any fees other than rates of fees mentioned in the application form for recognition and shall obtain permission of Deptt. of Education for any change in rates of fees.
10. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school.
11. That the service contract between the management and the employees shall be executed immediately.
12. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
13. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.
14. That the school society shall ask apply for the allotment of land and will construct the building as per the specifications of Dte. of Edn., Delhi within a period of three years.
15. That the Management of the school shall provide all the facilities as per rule 51 and all conditions as required under rule 50 shall be complied with. Provisions of Rules 6, 7, & 9 be strictly observed.
16. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.

10. Managing Committee of the school shall not increase fee in future academic session without prior approval of Director of Education which is a mandatory requirement under sub-section (3) of section 17 of DSER, 1973.
11. That all the facilities prescribed under rule 50 & 51 of the DSER, 1973 shall be made available to the students.
12. Proof to the effect that qualified staff has been appointed as per R. Rs. be provided for the verification of E.O.
13. That the arrangement for good drinking water shall be made available to all the students as well as to the teachers & sanitary facilities shall also be provided to the students adequately.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing secondary school to senior secondary level with effect from 1994-95 session. Sr. Secondary classes will be run without aid subject to the fulfilment of the following terms and conditions-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules 1973, as well as the instructions issued from time to time.
2. That the school shall admit the students without any discrimination of caste and creed.
3. That the school will meet the additional liability of senior secondary classes by appointing more staff as per the norms of the department and subjectwise PGTs shall be appointed and Govt. nominee shall also be invited at the time of the selection of the Teachers.
4. That the proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student and more approved standard books for senior classes and reference books for teachers shall be added by July, 1994, and a qualified librarian be appointed.
5. That more sport material for out-door games shall be purchased and made available to the students immediately during 1994-95.
6. That the school shall strictly abide by the provisions of Section 10 (i) of the Delhi School Education Act 1973, and payment shall be made through crossed cheque. Bonus, LTC, medical allowance, gratuity and pension as applicable to Govt. Employees of Delhi Administration shall be paid to the employees of the school.
7. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school and each class room, science labs, and library rooms may be fitted with proper electrical appliances.

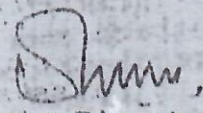

13. That the school building shall be constructed within a period of two years.

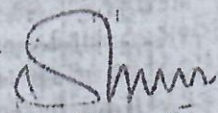

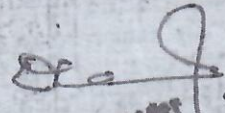

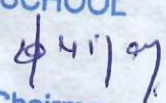
